Mandatory Producer Responsibility Scheme on Glass Beverage (GPRS) Containers

Starting from 1 May 2023, it has become a legal requirement in Hong Kong that any person who manufactures imports and "distributes" glass-bottled beverages locally must first register with the Environmental Protection Department, and satisfy its statutory obligations, including submission of returns, keeping records relating to the returns, payment of container recycling levies (HK\$0.98 per litre volume), submission of annual audit reports, etc.

According to Product Eco-responsibility Ordinance, Cap. 603, "distribute" means:

- (i) supply the equipment by way of sale, hire or hire-purchase;
- (ii) exchange or dispose of the equipment for consideration; or
- (iii) transmit or deliver the equipment for any of the following activities: supplying by way of sale, hire or hire-purchase; an exchange or disposal for consideration

As requested by the Government of Hong Kong, exhibitors involved in distributing glass-bottled beverage are required to register as a qualified supplier.

In order to facilitate and simplify the process for exhibitors on this new levy, as a one-off arrangement, Hong Kong Trade Development Council (HKTDC) will coordinate and handle the GPRS registration process for exhibitors.
